Starting next year, nearly all 25 public and private managed care health insurers participating in California's Medicaid program plan to offer nontraditional services (called "<u>in lieu of services</u>" in bureaucratic speak) from 14 broad categories, such as housing and addiction care. Services will vary by insurer and region.

The services, which will range from deliveries of healthy meals to mold remediation in homes, are meant to help high-need patients avoid expensive medical care, such as hospitalization.
